2. TOES agrees that it will keep records of all donations from all Donors for this activity, and the funds received will be kept in a separate bank account for the purpose of progressing the Judicial Review and any other associated expenses.
3. Costs incurred by TOES for the initial consultation and document preparation for the Judicial Review application, and any additional subsequent expenses incurred over the period of the Judicial Review action will be paid from this bank account and recorded in a statement of income and expenses, to be prepared for an account date of June 30, 2009 and annually thereafter if needed.
4. If it is decided to terminate the process of the Judicial Review application at any time, then after all obligations and liabilities have been paid from this bank account, and if there is any remaining balance, then a final distribution of any monies remaining in the bank account will be made to each Donor of \$100 or more on a pro rata basis based on each original donation amount as a percentage of total donations.
5. If on completion of the Judicial Review process, the court directs reimbursement of some portion of costs incurred by TOES, from the other parties, and if those costs are paid to TOES, then the net of the amounts of costs recovered less expenses incurred will also be distributed to each Donor of \$100 or more on a pro rata basis based on each original donation amount as a percentage of total donations.
6. There exists no further liability for any Donor beyond the original amount of the donation to TOES.
